**Minimum 1 month rental required**

- 1. Rented Equipment:** MESA hereby rents to Renter, and Renter hereby hires from MESA, the equipment described above in this agreement, hereinafter called "Rented Equipment".
- 2. Rental Period:** The Rental Period begins 3 days after the date Rented Equipment ships from MESA and ends upon its arrival back at MESA. The minimum Rental Period is 1 month.
- 3. Rental Payment:** Payments are invoiced at time of shipment. Standard payment terms are either Payment in Advance or Net 30 with established credit unless otherwise negotiated.
- 4. Delivery (Shipping & Handling):** The Renter is responsible for all shipping and handling charges to and from their facility. MESA will ship via FedEx 2nd Day or FedExNext Day, FOB Lakewood.
- 5. Return of Equipment:** Renter shall return Rented Equipment to MESA, at Renter's expense in the original packing materials and in good condition by prepaid, insured shipment to MESA's Lakewood, Colorado facility. If Renter fails to return the Rented Equipment within three (3) days after the end of the rental period, the Renter agrees that MESA will have the option to extend the rental period under the same terms, or charge the customer an additional 1 month rental.
- 6. Loss of Equipment:** In the event that the equipment is lost there will be a charge of 50% of the then current End User List Price.
- 7. Insurance:** Insurance will be at Mesa's expense, relating to loss or damage while the Rented Equipment is in transit. The Renter agrees to assume the risk of loss or damage of the Rented Equipment while at the Renter's facility. The Renter agrees to exercise due and ordinary care in the placement, use, maintenance and storage of the Rented Equipment at their facility so as to ensure its safe operation and proper functioning.
- 8. Ownership, Safe Keeping and Repairs:** The Rented Equipment is and shall at all times remain the property of MESA unless the Renter purchases it from MESA during the Rental Period. Renter is responsible for the safe keeping of the Rented Equipment and shall bear the risk of any loss, theft, damage or destruction of the Rented Equipment. Damaged Rented Equipment found to be the result of misuse by the Renter will be repaired by MESA at Renter's expense under MESA's standard Return Goods Authorization (RGA) procedures. In the event that Rented Equipment is not repairable, the Renter will be responsible for its full list price. The Renter will be invoiced for repair charges during the Rental Period or after the Rented Equipment has been returned to MESA. Warranty repairs will be completed on Rented Equipment found to be malfunctioning as a result of defects in material and/or workmanship under MESA's Standard Product Warranty. Renter down time due to any repairs will be compensated by a no-cost time extension of the Rental Period by the number of days required to repair and return the Rented Equipment to the Renter.
